#### Planning Application PA15/08900

To consider planning application PA15/08900: Mr J Broome, Crealy Cornwall. Construction of holiday and leisure park comprising 236 units of holiday accommodation, leisure facilities, exhibition space, convention centre, ancillary services and service buildings, restaurant, café, public house, and retail use, provision of ponds, landscaping and associated infrastructure. New access to be taken from B3274.

The application was discussed at length. Mr J Carhart proposed that the Parish Council make representation not to support this application. Mrs Sue Sleep seconded. Majority in favour of not supporting this application on the following grounds:

Negative visual impact, noise and light pollution, scale out of keeping with the landscape and character of the area, negative impact on environment and biodiversity in the vicinity, inadequate assessment of the impact on wildlife, low level of local economic and community benefit, incomplete and inadequate flood risk assessment.

Councillors Kay Hawkins and Peter Hammett rejoined the meeting
