Flooding at Hal's Grave

Drain by phone box in St Issey (East ie Wadebridge side of phone box) – water is running across road to drain opposite.

Zanzig on corner by Zanzig House drain is blocked and needs clearing out.

Trevance Hill – water running across road- drain is too small for the amount of water.

This suggestion is supported by the Councillors and the suggested location by the bollards seemed the most sensible place spot. Still no news - await any further developments on possible funding from the Area Network and further news from Cllr Rushworth.

Further discussion took place about parking in the village with various views being put forward regarding the safety of the village, the possible use of the village hall car park and the issue of the resulting maintenance and associated costs re the car park. It was proposed by Mr J Carhart, seconded by Mrs K Hawkins and agreed by all that an article could be placed in the Comma to explain that the Parish Council is in discussion with other groups in the village regarding ways to alleviate the parking problems in the village.

Mrs C Carter declared her interest and left the room. 2 quotes have been received for the grass cutting at Sentry Close. Cllr Rushworth had agreed to find out more information on an agency agreement, using the quotes to help him. These are to be forwarded to Cllr Rushworth with a view to having the agency agreement to support the contractor. To be reconsidered at the January meeting once all relevant information has been provided. Mrs C Carter returned to the meeting.
