PA18/01456/Preapp, Mr and Mrs E Stanton, The Pickwick, Burgois, St Issey. Preapplication advice for proposed new holiday cottages and new fishing lake. (Case Officer: S Hewitt)).

The Councillors agreed that they would await the planning application before making any comments.

PA18/03624 Planning Protocol – re Trenance Cottages, St Issey. Erection of replacement attached cottage. (Case Officer S Hewitt) The Councillors had previously supported this application. The planning protocol was received because the planning officer disagreed. There were 3 options – the councillors chose option 1 ie to agree with the planning officer's recommendation to refuse on the grounds that the rear projection of the dwelling would be large and dominating mass on the boundary of Bessie's Cottage and would block light to the dwelling and garden. Proposed by Cllr J Carhart, seconded by Cllr G Henwood, majority in favour of option 1, one councillor abstained. Planning officers are supportive in principal of a replacement dwelling but this should not harm the enjoyment of the neighbouring property.
