Mr G Henwood proposed support, Mr E Ballard seconded, majority in favour.
- 2. PA17/04883 Mr R Barrett, Copper Beech Grove, St Issey, Wadebridge. Revision to approved site layout to (PA1203118) to provide 7 open market dwellings (Plots 1-7) 8x2 bed apartments (affordable units) and service building. Revised plans now submitted incorporating the revisions for plot 10. Mr J Carhart proposed support, Mr D Heard seconded, majority in favour.
- 3. PA17/06831 Mr C Crooke Ballaminers Farm, Ballaminers Lane, Little Petherick. Non material amendment for masonry stack to replace metal flue above garden room roof; cill to be lowered beneath window of bedroom 3 to provide French windows and masonry infill not removed below bathroom window to decision PA17/00125. Mr J Carhart proposed support, Mr G Henwood seconded, majority in favour.
- 4. PA17/06689 Mr R Palmer Arqiva Ltd, Higher Hawksland Farm, Road from A389 between Trevance road to Hals Grave to Junction South of Hawksland, Far St Issey, Wadebridge. Removal of condition 1 of application ref No 1999/0518 dated 29<sup>th</sup> June 1999 as installation has been in existence for approx 18 years. Mr G Henwood proposed support, Mr D Heard seconded, All in favour.

## **Highways Issues**

Sentry Close – potholes – Cllr Rushworth will report this to Highways.

The manhole by High Lanes, approx 250 yards from junction, has sunk in the middle - to be reported to BT The road signage by Banjo Lane/Ring o Bells (no through road/no access) has gone. Request someone from Highways to meet Councillor to request signage be reinstated and also to explain what signage should be there and where it should be located in relation to the junction.

## **Recreation Ground**

Correspondence received from Mr Merrick, the Parish Council's solicitor. He had received notification that the invoices for rent sent from the Glebe solicitors to the Parish Council had been incorrect. The rent should have been £500 (not £400) therefore the Parish Council owes another £200. Mr D Heard proposed this be paid. Mr J Carhart seconded. All in favour.
